Depending on how you interact with us, we may collect:

- Name

b) Purchase & Transaction Data

- Billing address
- Payment information (processed securely by our payment provider – we do not store full card details)
- Order history

c) Technical & Usage Data

- IP address
- Browser type
- Device information
- Pages visited
- Interaction data

d) Marketing Preferences

- Newsletter subscription status
- Email engagement (opens, clicks)

3.How We Use Your Data

We use your data to:

- Respond to enquiries
- Deliver purchased products and services
- Manage customer accounts
- Process payments
- Send newsletters (where you have opted in)
- Improve our website, products and content
- Comply with legal and tax obligations

4.Legal Basis for Processing

Under UK GDPR, we rely on the following lawful bases:

- Contract – where processing is necessary to fulfil a purchase
- Consent – for newsletter marketing communications
- Legitimate interests – to improve our services and respond to enquiries
- Legal obligation – to comply with accounting and regulatory requirements

You may withdraw consent to marketing at any time via the unsubscribe link in our emails.

5.Platforms & Third Parties

We use trusted third-party providers to operate our business. These may process personal data on our behalf, including:

- Wix – website hosting
- Kajabi – digital product platform
- Kajabi Payments – payment processing
- Google Analytics – website analytics
- Mailchimp – email marketing

These providers are contractually required to protect your data.

6.International Data Transfers

Some of our service providers are based outside the UK. Where personal data is transferred internationally, appropriate safeguards are in place in accordance with UK data protection law.

7.Cookies & Analytics

Our websites use cookies and similar technologies (including Google Analytics)to:

- Ensure site functionality
- Analyse usage
- Improve performance
